Official Sweepstakes Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

SWEEPSTAKES DESCRIPTION:

The KKBXX-FM ("Station") ScreamWorld Orlando FlyAway Sweepstakes ("Sweepstakes") will begin on Thursday, September 30, 2013 at 6:00 a.m. Central Standard Time ("CST") and end on Sunday October 20, 2013 at 11:59 p.m. CST ("Sweepstakes Period"). This Sweepstakes will be conducted exclusively online. One (1) winner selected at random will be awarded one Grand Prize vacation for two to Orlando Florida including a) (2) airline tickets from Houston to Orlando, b) two nights hotel for two, c) two one-day passes to Universal Studios in Orlando, Florida. Said Grand Prize must be taken between January 2013 and June 2014. The Grand Prize winner has the option of taking the Grand Prize vacation, valued at \$0000 OR take a "cash out" of \$1,000 net.

HOW TO ENTER:

Listeners of KBXX-FM who are legal residents of the United States residing within the Houston/Galveston, Texas metropolitan area, who are eighteen (18) years of age or older at time of entry will be able to take part in this Sweepstakes. To participate in this Sweepstakes, participants must do the following:

- 1. To enter, participants must accurately complete an online registration form at http://www.theboxhouston.com ("Sweepstakes Website"). Participants must follow the link from the Contest page to the "ScreamWorld Orlando FlyAway Sweepstakes page.
- 2. Upon entering the Sweepstakes website, participants are to follow the on-screen instructions, including entering their name, date of birth, address, phone number, email address, any optional or additional contact information, as requested.
- 3. After completing the registration process, qualified entrants will be eligible for a chance to win.
- 4. All Internet entries must be received by 11:59pm CST on Sunday, October 20, 2013 or they will be void.
- 5. One entry per person, per day, per email address during the Sweepstakes Period.

- 6. On Monday, October 21, 2013, KBXX-FM will select one (1) winner at random from all eligible Sweepstakes entrants that entered electronically. The winner will be notified by phone and / or email. Prizes will be awarded upon winner verification and final approval by KBXX-FM.
- 7. In the event of a dispute regarding the identity of a participant's entry, the entry will be deemed to have been made by the authorized holder of the email account at the time the entry was made.
- 8. Winner must provide valid identification (i.e. via driver's license, passport or other government-issued photo I.D.) within 3 days of notice at the Radio One Houston offices, 24 Greenway Plaza, Suite 900, Houston, Texas 77046. Winner must sign and date official station release and waiver forms, an Affidavit of Eligibility and Publicity/Liability Release form as requested, and return to the station by either email or fax to claim the Prize. Identification documents must match information previously provided to the Station.
- 9. All decisions made by the Station and Radio One of Texas II, LLC ("Company") management regarding any aspect of this Sweepstakes are final.

ELIGIBILITY RESTRICTIONS:

- 1. The Sweepstakes is open to listeners of KBXX-FM who are who are eighteen (18) years of age or older, at the time of entry and are legal residents of the United States residing within the Houston/Galveston, Texas metropolitan area.

- 3. To the extent that prize elements are provided by third-party providers, winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.
- 4. Prizes must be claimed at the station's offices within three (3) days of the date of winning.
- 5. Dates and times of concerts, performances, activities, and trips promoted by Sweepstakes sponsors are subject to change and those changes are deemed to be beyond the control of KBXX-FM, and Radio One of Texas II, LLC. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KBXX-FM, and Radio One of Texas II, LLC are not obligated to make any effort to find an alternative prize under these circumstances.
- 6.
